The credits can be counted in the graduation credits, but students still need to apply for the recognition of credits according to NCHU regulation. These courses do not count towards the credits required for graduation. If master's students haven't yet completed the basic undergraduate courses requirement, they will not be eligible to take the graduation examination.</p>

The student shall choose a full-time faculty members of the institute as thesis advisor(s) before the end of the first semester.</p> <p>2. Every graduate student has to acquire the REE course certificate before applying for her/his final thesis exam, and the department will make the decision on whether each graduate student fulfills the REE requirements.</p> <p>3. The student who has reached the minimum period of study, completed required courses, credits, and also registered in that semester, can apply for Master Degree Examination in that semester and at least 20 days before the date scheduled for the examination. Students, who fail the Examination and are still within the time limitation of study, are allowed to apply for a re-examination in the following semester or academic year. Students who fail the re-examination will be dismissed from the Master program.
