Students are dropped from the course if the conduct score drops below 70. The course grade average accounts for 50% of the graduation score. Students matriculating directly into the Ph.D. program from a master's program before finishing the master's program may apply a maximum of 12 credits from their master's program towards the Ph.D. credit requirement for graduation. Students matriculating directly into the Ph.D. program without completing a bachelor's or master's program in applied economics may apply a maximum of 21 credits (half of the Ph.D. credit requirement excluding dissertation) from previous academic programs toward the Ph.D. credit requirement for graduation.

1. 必修科目不及格應予重修，必修科目未修滿不得畢業。

1. Students who fail a required course must retake and pass it before graduating. All required courses must be passed before a student is allowed to graduate.

2. Master's level and Ph.D. students must take at least one course from the following groups before graduation: agricultural economics, environmental and resource economics, and industrial economics.(2005/10/20)

七、系(所)指定應補修基礎科目(不計入畢業學分)：

博士班同學於碩士班未修過「個體經濟理論」、「總體經濟理論」及「計量經濟學」三門課程者，入學後須補修，但不列入畢業學分計算。

七、 Departmental requirement of basic subjects (not included within the credits required for graduation):

If a Ph.D. student has not previously taken "Microeconomic Theory," "Macroeconomics" and "Econometrics" in their master's program, they must select these courses after enrollment. The credits of these courses do not count toward the graduation requirement.

八、博士班研究生考核：

博士班研究生於入學後第一學年結束前，應經系(所)主任之同意商請指導教授。

未於規定期限內商請指導教授者，勒令休學一學期。

If a student doesn't invite an advisor before the deadline, their studies will be suspended.

八、 Ph.D. student evaluation:

A Ph.D. student must select an advisor and obtain permission from the Departmental Director before the end of the 1st academic year.

九、博士候選人資格考核：研究生修完最低修業年限並修滿規定應修科目及學分，且撰妥學位論文計劃大綱及基本內容，始得提出博士候選人資格考核，並經考核委員會三分之二以上之委員通過，始為合格。

博士候選人資格考核不合格者，不得提出論文考試，經重考一次仍不合格者，予以退學。

九、 Qualification examination for Ph.D. candidates:

Ph.D. students may apply for the qualification exam after finishing 2 years of study, completing all courses and credits, and finishing the outline and basic content of the dissertation. The student will pass the qualification exam upon approval from two third of the committee members.

A Ph.D. student cannot apply to defend their dissertation if they did not pass the qualification exam. A Ph.D. will be dropped from the graduate program upon their second failure of the qualification exam.

Ph.D. students should acquire the REE course certificate (approved by the department) before applying for their final thesis exam.</p> <p>2. A Ph.D. student may apply for dissertation defense after passing the qualification exam, completing the dissertation, and finishing registration and course selection for the semester. They must apply 20 days in advance of the scheduled date of defense. 70 is the passing score.</p>	<p>論文考試成績佔畢業成績 50%。</p> <p>研究生得透過臺灣學術倫理教育資源中心網站自我學習，並通過總測驗取得修課證明；各系（所、學位學程）另訂有應通過專業學術研究倫理教育研習課程者，則依各系（所、學位學程）另訂之規定實施。</p> <p>論文不及格而修業年限未屆滿者，得於次學年或次學期申請重考一次，重考仍不及格者，予以退學。重考及格者之成績，概以 70 分計算。</p> <p>The dissertation score accounts for 50% of the graduation score.</p> <p>Graduate students have to complete the ethics course(s) administrated by the Center of Research Ethics Education (REE) at the online self-learning website (<a href="https://ethics.nctu.edu.tw/intro/">https://ethics.nctu.edu.tw/intro/</a>), pass the related REE test(s), and then acquire the REE course certificate. For those departments and graduate institutes with other ethics course requirements established and enforced, such departmental or institutional ethics course requirements may supersede the REE course requirements.</p> <p>If a Ph.D. student fails to defend their dissertation successfully but still hasn't been in the program longer than the allowed time, they may apply to defend again in the next semester or next academic year. They will be dropped from the graduate program upon a second failure. A score of 70 or higher is required to pass.</p>
